

Additional Charges Policy U.S.

In accordance with your Training Agreement additional training and associated charges may be payable by you during the course of your training. These fees will be payable as incurred and failure to pay may result in your training being suspended should you fail to pay.

These fees include:

- > Ground School Repeat Fee – If you fail, elect, or are required to repeat theoretical training, you will be charged the cost of retaking.
- > Written Knowledge (FAA) Test Fees – FAA written knowledge test fees are required to be paid directly to the test vendor by the student for each test attempt. You are responsible for adhering to all test policies established by the FAA and Academy.
- > Additional Flight / Overflight Hours – if you are required to complete additional flight hours (in an aircraft or simulator) either because:
 - > you failed to achieve the required performance standard within the allocated syllabus time; or
 - > you fail to attend a scheduled flight without giving the required notice
 - > you fail to prepare for any ground or flight training activity on time, then each additional flight hour will be chargeable. Note that this excludes flight hours that cannot be completed as a result of poor weather, aircraft serviceability, ATC, other aircraft or airport related restrictions and or ill health where suitable notice has been provided.
- > Flight Test Fees (ACR/DPE) – if you fail to pass any flight test due to poor performance, failure to attend and/or late cancellation then any rescheduled flight test will be chargeable at the applicable rate in addition to any additional flight hours that may be required to complete the failed or cancelled test. Note that this excludes cancellations and/or instances where a test cannot be completed as a result of poor weather, aircraft serviceability, ATC, other aircraft or airport related restrictions, or ill health where suitable notice has been provided.
- > Deferral Fees – if at any point you choose to defer your enrolment start date (prior to training start) or wish to defer to a later course (after training has commenced) then a \$500 deferral fee will be payable for each deferral. Note if deferral also results in additional instruction, flight hours, ground school or testing, these fees will be payable in addition to the deferral fee.
- > Minimum Balance – for all courses with a price over \$4,000 a positive balance of \$1,000 is required to continue training. Should your account fall below this threshold at anytime then Acron Aviation reserves the right to suspend your training.

RESCHEDULE AND CANCELLATION

MAINTENANCE In the event your activity needs to be cancelled due to maintenance, a maintenance discrepancy log must be submitted when cancelling the event. Maintenance cancellations extend until wheels-up.

WHEELS UP In the event your activity is ended early due to any situation after the aircraft goes “wheels up,” it is no longer eligible to be cancelled. You will be charged according to the amount of time the aircraft was in use.
